Meeting called to order: 7:34PM

- I. Opening Remarks: Michael Graves thanks everyone for their continued hard work and looks forward to the rest of the year and 2025. Company commanders should compile numbers for the remaining events.
- II. Meeting minutes, August 13, 2024 approved
- III. Quartermaster Updates:
 - a. One tent was sold;
 - b. several muskets are waiting to be sold to new buyers and a couple repairs are lined up;
 - c. Lenny Torto has been working with current recruits to outfit them based on company.
 - d. Escutcheon plates are currently being collected to be engraved with rack numbers
- IV. Paymaster Updates: Rev250 will be issuing a \$25/man stipend for the Somerville powder alarm
- V. Recruiting Updates:
 - a. Recruit Tim Kelly had his meeting, with the Recruitment Committee and will discuss with serjeants at drill to pick a company.
 - b. Another young recruit, age 15, is going to try to get to September drill.
- VI. OSV De-Brief Meeting:
 - a. Overall, OSV were happy with the event.
 - b. There was one issue where one of the interns was underage and was served alcohol during the Tavern. This was an OSV internal issue.

- c. Early entry for vehicles on Sunday if there is a storm was discussed. OSV said that the 5:15PM time was non-negotiable.
- d. OSV seemed non-committal on host units but then asked 10th and LMM to be host units again. Michael Graves and Dylan Potter will attend the first meeting on October/November and discuss if the Regiment would like to move forward as a host. If we are not the host, we can offer guidance to the new host.
- e. OSV would like to add more programming, conflicting with reenactors' opinions that the lightened schedule was favorable.

VII. Musket age limits:

- a. Question to lower the age to carry muskets from 15 to 14 at drill and parades.
- b. Discuss the ability of members <15 being able to handle a musket safely.
- c. Possibility to have loaner muskets or mock-muskets available at drill, but do not permanently issue them.
- d. Option to change our by-laws to raise the recruitment age to 15
- e. Table the discussion until the October Staff Meeting

VIII. Attendance at remaining events:

- a. Arlington will pay \$500 for our participation in the Monument Dedication. We should strive for at least one person from each company to be there.
- b. Fort Ti is looking to have a good turnout
 - i. Cooking will be done by company but the Regiment will eat together
